Supplementary Data Privacy Notice

We understand that privacy is important to you. We are committed to treating your personal information (PI) with care and integrity.

Under data protection laws, we are required to provide you with certain information about how we use your PI, what PI we process about you, how long we keep it and on what lawful basis. This information is provided in this supplementary privacy notice, and it is important that you read it.

This notice supplements and should be read in conjunction with the consent forms for photo, audio and video (festivals / cricket days / residential / cricket sessions)

How do we use your personal information?

Photo, audio and video can reveal information about personal background and attitudes as well as sensitive information around health, disability, ethnicity and age. These may also provide an individual an opportunity to share their experience with a wider community. This would include how the Lord's Taverners have provided help and support through their work.

Videos, audio and photographs of groups and individual participants are collected. These are used on our, and those of our authorised third party providers, social media channels and in local and national media, including radio, television and print, in printed materials which could include, but not limited to, leaflets, posters, reports, newsletters to promote or celebrate the value of our programmes and the difference they make to those participating in them.

With whom do we share your personal information?

Videos, audio and photographs of our work and participants may also be used by our authorised third party providers, funders and supporters as part of their communications, which they would only undertake with our express written consent.

Access to individualised data is restricted to authorised third party provider(s) staff and Lord's Taverners staff. Appropriate security controls are in place to control access and ensure confidentiality of data.

Your information may be stored on computer systems belonging to or controlled by Lord's Taverners and authorised third-party service providers and may be transferred to countries other than your country of residence.

Lord's Taverners agreements with third-party service providers require that they and their service providers protect your information from unauthorized use or disclosure, and, where transfers are made outside of your country of residence, that these service providers ensure appropriate measures are in place to protect your personal information (such as data transfer agreements that incorporate standard data protection and information security clauses).

Personal Information Categories

Where required, we may process PI such as:

- First and last name, initials,



- Contact details including address, email address, contact phone numbers (including emergency contact)
- Health or disability
- Work country and location (site)

In addition we will also process sensitive personal information such as:

- Gender
- Ethnicity
- Date of birth

On what basis we use your personal information?

We collect and use your personal information for the legitimate interests of Lord's Taverners, including those described above in *"How do we use your personal information?"* This does not apply if our legitimate interest is overridden by your interests or fundamental rights and freedoms.

How long do we keep your personal information?

All personal information is kept in line with the Lords Taverners Retention Policy which is available on our website or by emailing Data@Lordstaverners.org.

In some jurisdictions, laws and regulations tell us how long we must keep your personal information. How long depends on the laws of the jurisdiction you are in when you share the information with us.

Data Controller

We have a contractual agreement with our delivery partners that together the Lord's Taverners and they and are the joint controllers of your personal information.
